# **Key Topics of the Stakeholder Newsletter February and March 2017:**

#### UNREST - Work Packages 3, 4, 5 and 6

Welcome to the UNREST newsletter for the Spring of 2017. In the last two months, significant work has been carried out on our empirical work packages and we have continued to engage with our stakeholders. We are beginning to plan first publications resulting from our research. Further details of the work carried out in each Work Package can be found below.

#### **Work Package 3: Exhumations**

On January 30 and 31, 2017 WP3 celebrated the first workshop with stakeholders in exhumations of mass graves of the Spanish Civil War at the Spanish National Research Council (CCHS-CSIC) in Madrid. The idea behind these workshops – which will also be organized in Poland and in Bosnia and Herzegovina – is two-fold. On the one hand it is an opportunity to present UNREST to the different stakeholders in the field, and on the other hand it is a laboratory for empirical enquiry.

In order to represent the diversity – geographical, activists' organizations, academic disciplines – of the field of stake-holders in Spanish exhumations, we designed one and a half day of continuous debate divided in thematic sessions combining representatives from different regions and stakeholders groups: institutions, victims organizations/memory activists and academic specialists.

While preparing for our fieldwork in Poland and Bosnia, we are looking back to a successful discussion on contemporary memory politics in Spain, where many of the stakeholders met for the first time and started a conversation, which we hope will coordinate future memory work in Spain.

#### **Work Package 4: War Museums**

WP4 has been very active in the first months of 2017. We are in the process of completing the initial stages of our research and producing reports about each of our museums before moving on to the visitor studies phase and writing up our findings in various collaborative articles. In January the whole team spent a busy few days in Poland. We visited Schindler's Factory, Krakow, and spoke to the curators there, as well as Plazów Camp and The Eagle Pharmacy. Some of us also took the train to Warsaw and visited the magnificent POLIN Museum, perhaps our first agonistic museum, and the following day had a very sobering experience at Auschwitz-Birkenau. In March we all met in Péronne in the Somme to visit the last of our museums, the Historial de la Grande Guerre. We had fruitful discussions with the curators and director there and visited other sites in the area including Thiepval, where the visitor centre is run by the Historial.

On 5 April 2017, UNREST researchers at the University of Bath presented the project to regional stakeholders, including museum professionals and artist-practitioners, at a research showcase on difficult history in museums.



#### **Work Package 6: Creation of cultural events**

WP6.2 is in the process of designing an exhibit that critically engages with memories of WWI, WWII, the wars in Yugoslavia, and the war in Syria. We are not dealing with these wars in chronological sequence. Instead, the different segments of the exhibit focus on feelings that play a decisive role in the construction of war memories. The working group is currently tackling the challenge of identifying objects and media texts that can effectively express emotions like fear, shame, or pride. Obviously we are paying particularly close attention to the type of war memories and emotions that are sidelined in cosmopolitan remembrance of modern warfare.
